Will antidumping and countervailing duty push up solar module prices?

Are crystalline solar cells affected by US anti-dumping duties?

The US Commerce Department set final countervailing and anti-dumping duty rates on Monday for crystalline solar cells and modules imported from four southeast Asian countries. Cells and modules from Vietnam, Malaysia, Thailand and Cambodia are affected. Importers have already been posting cash deposits for the duties since last fall.

What are the anti-dumping and countervailing duties on solar panels?

The countervailing and anti-dumping duties are in response to a petition that a group of seven solar panel manufacturers called the American Alliance for Solar Manufacturing Trade Committee filed with the US government in April 2024.

Is there a loophole against solar manufacturers in Cambodia?

Viewing this as a significant loophole, the American Alliance for Solar Manufacturing Trade Committee brought a new AD and CVD petition against solar manufacturers in Cambodia, Malaysia, Thailand, and Vietnam directly.
